Additional research topics will be identified as more resources become available. Each report will include a collaboration team of corporate entities along with academic partners.

 - i. *Working topic*: Health Risk Communication and PFAS Water Treatment Technologies for Small, Medium, and Large Water Systems
 - b. WATER UTILITY PRIVATIZATION AND REGIONALIZATION (2024)
 - **i.** *Working topic*: Collaboration, Partnership, Regionalization and Privatization: A Closer Look at Water Utility Structures
 - c. WATER REUSE (2025)
 - Working topic: Opportunities for Water Reuse Where Water Quality is the Driver
- 2. Student Engagement through Capstone Projects Engaging with University of Pennsylvania's students and guiding them in their journey to become the next generation of leaders in the environmental sector (we hope they choose a path in water!) through a year-long capstone project is a value add for both our students and your organizations. Potential capstone projects will be identified by your organization and proposed to students to deliver a final product. Short-term and long-term research projects are encouraged.
